How do you respond to change? Is it unsettling, or even scary? Do you see it as an opportunity? Some of us thrive with change; others resist it all costs. Change is "making the form, nature, content, future course, of something different from what it is or from what it would be if left alone." One thing is certain: change is inevitable - in our personal lives, in our workplaces, in our culture.

2023 brought many changes to Hall-Dawson CASA. We experienced a change in board leadership and

membership. We welcomed some new staff members and volunteers, and others took a different path. We added new supporters and saw funding cuts from some. The most visible change was bringing on a new executive director, Carla Baker, as our long-time ED Janet Walden stepped aside to devote more time to her family.

For the 350 local children we served in 2023, changes came in ways that most of us cannot imagine. Children in foster care typically change placements (or homes) five times a year; they will likely have multiple DFCS case managers, attend several schools, even live in different cities. They are often far away from their friends, family and beloved pets. And their time in foster care is on average up to two years, but can extend much longer. Often, the only consistency in their young lives comes through their CASA Volunteer. In 2023, 95% of the time when a child's case closed, they had the same Hall-Dawson CASA Volunteer from the beginning to the end of their time in foster care. We are so grateful to our Volunteers for their consistency with our kids! Our CASA Volunteers daily embrace these words from Mary Davis, "We can't heal the world today, but we can begin with a voice of compassion, a heart of love and an act of kindness."

Children with a CASA Volunteer have measurably better outcomes. The majority experience fewer changes in placement, a shorter time in foster care, fewer visits to court, more success in school - and most important of all, they are more likely to find permanency. This is our mission: to ensure that every child has the right to a safe and permanent home. Every child deserves a place to call home, a place where they are safe and loved.

In 2024, Hall-Dawson CASA celebrates 35 years of advocating for our community's most vulnerable children and teens. We are grateful to all who have consistently walked with us along the way over these years, and for all listed on these pages who are supporting us today. We stand on the shoulders of those who have come before us and look to the future with those who partner with us. We will continue to advocate for kids, and seek to grow our CASA family, so that we may serve more children who need us.

Child Success Stories Consistency Matters

Consistency Matters

After two teen boys were brought into care for the third time, it became apparent that reunification - while always the first choice - was simply not going to be a reality. The CASA Volunteer started digging and looking for relatives to be the placement. After several attempts, the CASA identified a relative, connected them with DFCS, and they ultimately were awarded guardianship of the boys. The CASA remained a constant support for the boys and the relative throughout the process, visiting regularly, attending a concert, and even helping to identify funding for a summer camp. The CASA Volunteer was key to the boys finding permanency.

She learns about the children's needs and collaborates with DFCS, school staff, doctors, therapists and other treatment providers. She enjoys the ability to be creative and collaborative with them. Dian exhibits a persistence when faced with complex issues that sets her apart from other CASA Volunteers. Dian also volunteers weekly in the Clothing and Toy (CAT) Center.

We are grateful to Dian for her commitment to the children she serves, and for her willingness to share the CASA story throughout our community. "Ms. Hatfield's long-term dedication to her cases shows in her thoroughness. She has worked on a variety of different types of cases with different permanency outcomes. 


Lifelong Relationships

The impact a CASA Volunteer makes on a child is vital throughout the life of the case. Often the relationship continues long after the case closes. CASA Volunteer Cathy V. recently received calls from (now adult) children she served, whose cases both closed more than five years ago. One of the girls was asking for Cathy's guidance on receiving funding for college. The other was simply wanting to share that she now has a relationship with her Dad, which she had never had before. It meant a great deal to Cathy that both girls remembered her, reached out for help, and had good news to share.

Consistent Connections

Jasmine, raised by her aunt since her mother passed away during infancy, was removed from the aunt's home and placed in foster care. The barriers to her return to the aunt's custody were too great to overcome. The CASA Volunteer quickly jumped in and identified an adult cousin who ultimately became Jasmine's legal guardian. Finding this solution enabled Jasmine to remain with family, and to find permanency in surroundings that were familiar and comfortable for her.

It means having positive, healthy, nurturing relationships with adults who provide emotional, financial, moral, educational and other kinds of supports as youth mature into adults. Ideally, permanency takes the form of a relationship that has a legal component that provides a parent-child relationship. Older youth, regardless of age, need and deserve to be connected to a permanent family and support system that both lifts them up and cushions them if they fall."



Our Clothing and Toy (CAT) Center is a resource for our CASA Volunteers, DFCS partners and foster families to fill needs for children they are serving, and is located in the basement of The Little House. Community members, business partners and civic groups donate new toys, diapers, gently used clothing and kid-friendly furniture throughout the year. School supplies are collected and distributed before school begins in August, and toys at Christmas are available for CASA Volunteers to drop by and "shop" for their kids. This past year, 150 of the kids we served got the school supplies they needed, setting them up for a successful school year. Toys and gifts were provided for 172 kids ranging in age from infants to college students.

These are the "extras" that are important for our kids to have during a chaotic time in their lives. We are grateful that, in additional to the vital advocacy we provide, these needs are met by our generous community.

Reunifying Families

Often a major barrier to kids reunifying with their biological parents is the inability to provide adequate housing. In 2023, 157 of the kids we served had inadequate housing. CASA Volunteers regularly help parents identify resources to overcome this barrier. From roof repairs to finding adequate bedding, CASA Volunteers support families in the very practical ways that are pivotal in achieving permanency.

Comforting Through Consistency

A young girl we served had experienced horrific trauma in her life. As a result, she had displayed behaviors that made finding a consistent placement difficult. She was moved to several different foster homes in a brief time. Her CASA Volunteer, Sherry T., was diligently trying to keep up with this child's transitions and was having a difficult time getting in touch with the most recent foster family. Sherry T., being a tenacious CASA, was able to locate this young girl. When she arrived to visit, the girl looked at her with relief and a smile, and said, "I knew you would find me."



CASA is vital to our Juvenile Court Dependency proceedings. Often what a child wants and what is in their best interest does not align. Therefore, we rely on CASA Volunteers to give us the full picture of what is best for the child. CASA Volunteers are often able to obtain more information from children and parents than what is seen on the surface. Additionally, their gathering of information from schools, medical professionals, and others help give us so much more information that helps us make sure all of the children's needs are being met and that they are on track for reaching permanency.

Our CASA Volunteers also offer support and encouragement to parents who are working towards reunification and make lifelong connections with children. They are often the only "constant" for a family in a system that sees frequent turnover in DFCS Case managers and sometimes judges and attorneys."
